

Racers Take Note of Following Procedure:

1. Complete the Entry Form below; print legibly for accurate computer data entry and scoring.
2. All bikes need either permanent number/background or "colored sticky-backs". If you're a single day racer, new or have changed class, first go to **Transponder Services** for number assignment, transponder \$10 rental (\$30 deposit-\$20 return) or \$30 purchase, and reflashing transponder for class change. A number provided to you on a "colored sticky-back" is for use at this event only; permanent number/background required at subsequent event---rule enforced!!
3. Assure transponder is mounted horizontally on chest protector, numbers on are bike. Riders are then welcome to pass through Transponder self check/verification area multiple times. Go thru **Tech Inspection** for sound check and number verification for class. Your rider number will then be written on the entry form.
4. After passing **Tech Inspection** proceed to **Sign-Up** to show current NETRA membership card, join NETRA, or pay for Guest Pass. AMA membership not required. Minors need parent to fill out a waiver form. Pay entry fee for race.
